**SUB: Registration in Govt. of India Youth Portal as a COVID-19 Warriors -reg.**  
**Ref: Virtual National Planning Committee Meeting held on 30.04.2020.**

Dear Sir/Madam,

We take this opportunity to thank you for encouraging and motivating the members of the Bharat Scouts and Guides of your State Association for joining and supporting the State/District and Local administration by organising various yeoman service to combat against COVID-19 pandemic in the country with commitment and dedications.

I would like to draw your kind attention on the discussions held during Virtual National Planning Committee Meeting on 30.04.2020 pertaining to registration of our youth members i.e. Rover & Rangers and Unit leaders aged between 16-25 years in Govt. of India Youth Portal as COVID-19 warriors. During the aforesaid meeting Hon'ble Chief National Commissioner has '**appealed**' to all the State Chief Commissioners to issue instructions to the concerned officials in the State Association to monitor and ensure the registration of the youth members. In this regards, National Headquarters has circulated following circulars to all the states to initiate registration.

1. NHQ Circular No. 52/2000 dated 29.04.2000- Appeal to scouts & Guides, Rovers & rangers and Unit Leaders to Register in Goggle Form.
2. NHQ Circular No. 42/2000 dated 08.04.2000- iGOT (Integrated Govt. Online Training) Course on DIKSHA Platform on COVID-19 pandemic.

We once again "**appeal**" you to kindly intervene in this matter and ensure registration by Rover & Ranger and adult leader between 16-25 years of age in **Goggle Form issued vide NHQ Circular No. 52/2000** and register for iGOT Course on DIKSHA Platform issued vide NHQ Circular No. 42/2000 (**Copies of both the circulars is attached herewith**) immediately as we have to submit the list of registered youth members to the Ministry of Youth affairs & Sports by 15<sup>th</sup> May, 2020. **It is requested that the concerned official may be instructed to complete the registration of youth members in the Goggle Form latest by 12<sup>th</sup> may, 2020** positively so that the same may be consolidated and further submitted to the Ministry in stipulated deadline.
