1. Attention of members is also invited to Rule 40 of the Bharat Scouts and Guides containing conditions of eligibility to attend meeting of the National Council, which is reproduced below:-

Rule-40: "The State Association shall pay to the National Association annually such Affiliation Fee and such annual Individual Registration Fee as may be fixed by the National Executive Committee and approved by the National Council from time to time and in default of such payment within a period of twelve months after the closure of the financial year for which the fees are due or within such extended period of time by the Chief National Commissioner, being more than six months, the office bearers and elected representatives of the State Association on the National Council and the National Executive Committee shall not be entitled to attend, participate or vote at or stand for any election to the National Council and the National Executive Committee till such dues are paid." Hence clear all the IRF & Affiliation Fee dues, if any, up to 2017-2018 to avoid inconvenience. If still dues are pending, members are requested not to proceed.
